Dahn Gandell 3 4 Resolved, That the 86th Convention of the Episcopal Diocese of Rochester is in full support of the Episcopal Diocese of New York's India Network Resolution; and be it further 5 6 Resolved, That, The Episcopal Diocese of Rochester join with Episcopal Diocese of New York in sending a 7 Memorial with respect to caste and descent-based discrimination (as in the Adopted Resolution of the 8 Diocese of New York) to the Deputies and Bishops of the Episcopal Church to be assembled at the 79th 9 General Convention; and be it further 10 Resolved: The 86th Convention of the Episcopal Diocese of Rochester directs the Secretary of Convention 11 to forward copies of this resolution to both the Secretaries of both the Episcopal Diocese of New York 12 and the General Convention of the Episcopal Church. 13 **Explanation** 14 We have been blessed by the witness of both Roja and Prince Singh and their work for those who are 15 victimized by the caste system of India. We have been further blessed by a year of conversation and reading under the rubric of Seeing the Face of God in Every Person. 16 17 We welcome the leadership of the Diocese of New York in their resolution: Against Caste-and Descent-**Based Discrimination 2017** 18 19 **TEXT OF THE RESOLUTION:** 20 21 Resolved: that the 241st Convention of the Episcopal Diocese of New York send the following 22 23 to the Deputies and Bishops of the Episcopal Church to be assembled at the 79th General 24 Convention: 25 26 "Resolved: that the 239th Convention of the Episcopal Diocese of New York condemn the human 27 rights violation of discrimination based on caste and descent wherever it occurs and support its 28 elimination particularly as it occurs within the United States both within and outside the Church; 29 and further 30 Resolved: that the 239th Convention of the Episcopal Diocese of New York call on congregations 31 in the Diocese of New York to acknowledge the fundamental injustice of caste-and descent-32 based discrimination, a clear human rights violation; and further 33 Resolved: that the Episcopal Diocese of New York engage in legislative advocacy and education 34 to raise awareness of the pervasive nature of this human rights violation; and further 35 Resolved: that the Episcopal Diocese of New York charge the India Network with the preparation 36 of an e-mail document outlining caste-and descent-based discrimination and the atrocities 37 associated with it, such document to be distributed to all Diocesan parishes before the next 38 Convention of the Episcopal Diocese of New York. 39 40 **Explanation** 41 Many of our sisters and brothers in this Diocese have come to us from India. They bring us 42 personal witness to an issue currently prominent in our news media: Many of God's children,

43 especially women and bearers of alternative identity and preference, are subjected to horrific 44 violence. Among the victimized are people who have for millennia lived under caste-and 45 descent-based discrimination. These people have chosen the name Dalit for themselves. The 46 Dalit population worldwide is estimated to number more than 260 million people. 47 48 Ours is a concern shared increasingly on an interfaith level especially by those in our churches, 49 mosques, and temples who advocate for oppressed minorities everywhere. Because of our long-50 term relationship with our Christian partners in India, members of the India Network have 51 represented our Diocese at two events in our Nation's capital in support of the International
