MINUTES OF THE 84th DIOCESAN CONVENTION DRAFT

The 84th Convention of the Diocese of Rochester was held November 14th, 2015 at Hobart & William Smith Colleges in Geneva, NY.

OPENING OF CONVENTION/ESTABLISHMENT OF A QUORUM

The Rt. Rev. Prince G. Singh opened the Convention at 8:45 a.m. with a Gathering Liturgy and prayer.

Welcome

The Bishop extended a warm welcome to guests, convention delegates, and clergy to the 84th convention. A video greeting from newly elected Presiding Bishop, the Rt. Rev. Michael Curry, was shared with the convention. The Bishop introduced Mr. Mark Gearan, President of Hobart and William Smith Colleges. President Gearan welcomed delegates to the colleges. The Bishop then introduced special guest preacher, Heidi Kim, Bishop John Macholz, the Rev. Winfred Vergara, Missioner of Asian American Ministries, Mr. Loren Ranaletta and other special guests.

Ouorum

The Secretary established a quorum was present and the Bishop called the convention to order at 9:20 a.m. on November 14, 2015.

FIRST BUSINESS SESSION

The Bishop called the meeting to order and noted that all ordained Episcopal clergy functioning in charge of congregations by canonical residence or license with this Diocese shall have seat, voice and vote. According to ARTICLE III (c), the Chancellor, Secretary and Treasurer of the Diocese and Lay Canons also have seat, voice and vote except in the case of a vote by Orders.

Majority Vote

The Secretary established the numbers needed for a majority vote.

Introduction of the Chancellor and the Assistant Chancellors

The Bishop introduced the Chancellor, Philip Fileri, Esq. and the Assistant Chancellors, Thomas Wright, Esq. and Paul Green, Esq.

Introduction of Treasurer

The Bishop introduced the Diocesan Treasurer, Mr. Robert Van Niel, and thanked him for his fifteen years of "gentle service and profound wisdom".

Election of Treasurer

The Bishop explained the process to call a new treasurer and announced that he and the Standing Committee have nominated Mr. Terry Butwid to be Treasurer of the Diocese. The nomination was seconded and the motion to elect carried.

MSP

Appointment of a Chaplain

The Bishop appointed the Rev. Richard Eckhart as Chaplain to Convention.

Reading of the Minutes of the 83rd Diocesan Convention

The Bishop announced that the Committee on the Reading of the Minutes had reviewed the minutes of the 83rd Diocesan Convention as posted on the website and made available in print at all Pre-

Convention District Meetings. He called for a motion to waive the reading of those minutes and to accept the minutes of the 83rd Diocesan Convention.

Appointment of Registrar and Assistant Registrar

The Bishop appointed Ms. Kristy Estey to serve as Registrar and Ms. Carolyn McConnell as Assistant Registrar.

Committee on Elections

The Bishop appointed the Committee on Elections Ms. Joanne Wisor, Chair; Ms. Sue Adams, Ms. Margy Ashley, Ms. Patti Blaine, Rev. Georgia Carney, Rev. Michael Finn, Ms. Madeline Gamble, Mr. David Galleher, Mr. Bill Plew and Ms. Kristin Woodward, staff; and declared the polls open.

Committee on Credentials

The Bishop appointed the Committee on Credentials: The Rev. Dr. Billy Daniel, Mrs. Dianne Price and Mrs. Liz Porter from St. Michael's, Geneseo.

Seat and Voice as Reported by the Committee on Credentials

The Chair of the Committee on Credentials, the Rev. Billy Daniel, reported the credentials of the delegates were in order. He cited Article III, Section 2(c) of the Constitution and moved that the courtesy of seat and voice be granted to the guests of convention. Included were:

The Rev. Dan Burner, Chair of the Committee on Dispatch of Business, moved the agenda for the Convention.

Rules of Debate

The Rev. Dan Burner, Chair of the Committee on Dispatch of Business, moved the Convention Rules of Debate as follows:

- that all speakers must identify themselves by name, congregation and organization
- that no more than 15 minutes be devoted to each question, including amendments and substitutions
- that the sponsor and first opponent limit themselves to three minutes and all speakers thereafter are limited to two minutes

The rules of debate may be amended or extended during debate by a <u>simple majority</u> vote, if desired. Delegates were reminded that motions, amendments and substitutions should be presented to the Secretary in writing with the name and congregation of the mover, using the form found in the packets.

Closing of Nominations

The Bishop asked for a motion to close the nominations.

Taking of the First Ballot

The Bishop declared the nominations closed. Since there was no contest for Commission on Ministry – Clergy and Disciplinary Board –Lay and no further nominations from the floor, the Bishop asked for a vote on those offices by acclimation.

The positions were elected by acclimation.

The Bishop then asked the Chief Teller, Mrs. Joanne Wisor, to instruct the voters regarding the voting procedures, the location of the ballot boxes and the number of votes to be cast.

BISHOP'S ADDRESS

The Bishop began by acknowledging veterans, clergy retirements and transitions, new leadership, working task forces, diocesan committees, his family and others. His address focused on resurrection, reconciliation, evangelism and the need to focus outward – looking for God in the faces of those round us. The text of the Bishop's address is included in a separate section of the Journal and available on the diocesan website.

Reports to Convention

Deputation to General Convention

The Bishop recognized the Rev. Canon Denise Yarbrough of the delegation to General Convention to make a report to Convention. Individual members of the delegation reported on the highlights of the 78th Convention of the Episcopal Church of the United States.

Commission on Ministry

The Bishop recognized the Rev. Ken Pepin to give a report on the Commission on Ministry. Ken recognized the members of the COM and provided an overview of the work of the past year.

The 2014 Diocesan Audit Report

The Bishop recognized Mr. Robert VanNiel, Treasurer of the Diocese, to present and move the audit report. Bob thanked the audit committee of the Trustees and the audit firm, Bonadio & Co. LLC, for their oversight of the process. He reported that Total Diocesan Assets increased to approximately \$22M. That figure no longer includes "Parish managed funds" which were previously invested in the Combined Endowment (~ \$9M. as of 12/31/13). Operating expenses were 5% below budget and capital expenditures were ~ \$60K below budget, allowing for a lower draw from investments. Following discussion, delegates approved the following resolution:

Resolved: That the 84th Convention of the Episcopal Diocese of Rochester accepts the 2014 audit, as prepared by Bonadio & Co., LLC and presented by the Trustees.

Youth Activities

The Bishop called upon the Rev. Sara D'Angio White to report on Youth Activities within the Diocese. Sara was accompanied by many of the youth who participated in a youth team retreat held in April. The youth shared their experience using a variety of pictures from that retreat and ended their report with a song. A second retreat is planned for April 2016.

Colgate Rochester Crozier Divinity School (CRCDS)

The Bishop recognized the Rev. Winifred Collin, the Director of Anglican Studies, to report on CRCDS. She noted that the school has a "treasure" of courses and is a source of lifelong learning open

to all and offers an M. Div. and D. Div. She introduced the Rev. Andrew Van Buren, a recent graduate, who provided an overview of his experience.

Standing Committee:

The Bishop called upon Mr. Chris Moore, President of the Standing Committee, to provide a report. Chris recognized members of the committee and referenced the report from the Standing Committee included in the packet of Convention information. He noted the reconciliation conversation that the Committee has been undertaking with the facilitation of Bishop Joe Burnett.

Resolution B

The Bishop recognized the Rev. Paul Frolick to present Resolution B. Paul presented the following resolution.

RESOLUTION B

Resolution: Diocesan Year-Long Pilgrimage of Seeing the Face of God in Each Other

Resolved, that, with the 78th General Convention of the Episcopal Church this 84th Convention of the Episcopal Diocese of Rochester recommit to the work of responding to the continued systemic racism in our society; and be it further

Resolved, that this Convention declare a Diocesan wide "Year Long Pilgrimage of Seeing the Face of God in Each Other" with support of the Diocese, the Anti-Racism Committee and a Steering Committee appointed by the Bishop, and be it further

Resolved, that this Pilgrimage will conclude with a Day of Repentance, Healing, and Reconciliation in conjunction with the 85th Convention of this Diocese in 2016.

Explanation

The Episcopal Church program, *Seeing the Face of God in Each Other*, is designed to make us all more aware of how society's racist past still haunts us today. Through self-examination and sharing our

stories, we come to learn more about how our behavior affects others, and how our society, institutions and churches affect how we think and feel about others.

At each General Convention since 1991, the Episcopal Church has committed to address racism within our church, society, and the world. At the 78th General Convention this past summer, the church reaffirmed this commitment in Resolution A182: Using Education, Community Dialogue, and Internal Audit to Respond to All Forms of Racial Injustice (the text of that resolution is attached). Many of us recognize when obvious racism, discrimination or oppression occurs, but are unaware of the subtle racism that occurs everyday all around us and how we might be involved in perpetuating it. To better educate ourselves about the underlying racism in our daily lives and institutions, all lay and ordained leaders in the Episcopal Church are required to attend antiracism training. Each and every member of the church can be involved in the effort to end the institutional racism that exists in the church. Together we can make our church a welcoming place, devoid of racism. Each of has a part in eliminating racism in the church, society and world. In order to truly love our neighbors as ourselves, we must walk in one another's shoes and understand how our behavior affects those around us. Changing our own behavior is just the beginning; creating change in our institutions is the next step. While the church is a collection of its individual members, it will not change unless we work together to make change happen and to eradicate institutional racism from our churches.

BACKGROUND

78th General Convention Resolution A182: Using Education, Community Dialogue and Internal Audit to Respond to All Forms of Racial Injustice

Resolved, the House of Bishops concurring, That the 78th General Convention of the Episcopal Church recognize that many Episcopalians find it challenging to understand or know how to respond to 21st century systemic racial injustices that still occur in multiple contexts including but not limited to education; employment; housing; health care; banking; voting rights; immigration; policing, courts, and prisons, etc., be it further

Resolved, That the 78th General Convention affirms that the Gospel, our Baptismal Covenant, and our Marks of Mission call individuals, churches, dioceses, provinces, and the wider Church to find more effective and productive ways to respond to racial injustice as we love our neighbors as ourselves, respect the dignity of every human being, and transform unjust structures of society; and be it further

Resolved, That the 78th General Convention declare that "not knowing" and "not having the eyes to see and ears to hear" are serious obstacles to transforming unjust structures and therefore direct the Church at every level for this triennium to commit to increase the use of study, education, research, anti-racism training, liturgies, and Christian formation instruction that specifically address systemic racial injustice; and be it further

Resolved, That the 78th General Convention urge the Church at every level to increase the number of dialogues about systemic racial injustice it has with local, state and national bodies within the public and private spheres and that these dialogues be used to identify, examine, and offer correctives to policies and practices within and among these bodies that result in systemic racial disparities and injustices; and be it further

Resolved, That the 78th General Convention urge dioceses and congregations to create vehicles for listening to diverse neighbors and developing reconciling relationships; such options might include (a) listening campaigns in local communities, (b) partnerships with churches and organizations comprised predominately of a different race or culture (especially those targeted by oppression), (c) neighborhood prayer walks, (d) storytelling and speak-out events designed to facilitate truth-telling, healing and action, (e) and others with which leaders throughout the Church are familiar; and be it further

Resolved, That the 78th General Convention encourage Justice and Advocacy Ministries to partner with other church offices and organizations as appropriate to host, resource, and moderate an ongoing online forum for Episcopalians dedicated to the ministry of racial justice and reconciliation, with spaces dedicated to sharing about local and diocesan efforts and resources; and be it further

Resolved, That the 78th General Convention encourage Justice and Advocacy Ministries to partner with Youth Ministries to commission a gospel-centered, Internet-integrated, action-oriented, anti-racism youth ministry curriculum for congregations throughout The Episcopal Church, including those not in the United States, to be provided in English, Spanish and Haitian Creole; and be it further

Resolved, That the Standing Commission on Liturgy and Music produce and post online a set of prayers for racial reconciliation and justice, suitable for inclusion in the Prayers of the People; and be it further

Resolved, That the 78th General Convention urge the Executive Council to conduct its own internal audit to assess to what extent, if at all, racial disparities and systemic racial injustices exist within the Church (including but not limited to clergy salaries and deployment); and be it further

Resolved, That the 78th General Convention request that the Executive Council report back to the 79th General Convention on the results of the internal audit; what concrete steps it and the wider Church took to address systemic racial injustice in the wider culture; and how effective those steps were.

Following discussion, the Convention approved Resolution B.

MSP

Diocesan Council:

The Bishop recognized the Rev. Paul Frolick, the Rev. Chris Streeter, and the Rev. Catherine Tatem from Diocesan Council. Paul gave an overview of Council's work over the past year and introduced Chris who gave a short report on Congregational Development (CDPC) and Catherine who gave an overview of the work of the Mission Grant Committee (MPC).

Presentation of the 2016 Diocesan Budget

The Bishop recognized Rev. Paul Frolick, Vice-chair of Diocesan Council, who introduced Gwen Van Laeken, a member of Council and chair of the Budget Committee. Gwen reported on the process that the budget committee used to create the budget and introduced Todd Rubiano, CFM, to present the 2016 budget.

2016 Budget

Todd presented the 2016 budget with a review of sources of income (parish apportionments (46%) and draw from investments (54%)), budget projections for five years and the expense categories of the 2016 budget for the diocese. Apportionment remains flat for 2016 and the average rate is down 8% since 2011. Projected draw from investments is 6% with continual progress toward a goal of 5% within the next few years. The \$2.128M 2016 budget is a reduction of \$77.5K from 2015 with a goal of reducing expense by 3-4% over the next two years.

The Rev. Paul Frolick made a motion on behalf of the Diocesan Council for the approval of the 2016 budget. Following time for discussion, the following resolution was approved:

Resolved, that the 84th Convention of the Episcopal Diocese of Rochester approves the 2016 Diocesan Budget of \$2,127,666, as recommended by Council, with thanks to the Committees for their work and to all the Parishes through whom mission and ministry are undertaken.
